TRADEMARK ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, including the obligation of Assignee to attend to the next trademark registration renewal, Assignor hereby assigns and transfers to Assignee, its successors and assigns, any and all of its right, title and interest in and to the Mark in any and all forms in which they have been used and including any and all common law rights therein, as well as any registrations related thereto, together with any goodwill symbolized by the Mark. This Assignment expressly includes the right to sue for and collect damages for acts occurring prior to this Assignment and thereafter. The Commissioner for Trademarks is requested to issue any certificates of registration for the Mark to Assignee. The Parties agree that nothing contained herein shall be construed to grant to Novolex any right, title, or interest in or to any of Assignor's trademarks or any other intellectual property of Supplier except to the extent expressly provided herein

This Assignment shall be governed by the laws of the State of South Carolina without regard to conflicts of law principles thereunder. This Assignment shall be binding upon and inure to the benefit of the Parties and their respective successors and assigns.

This Agreement may be executed in one or more counterparts, all of which together will constitute one and the same instrument. A signature transmitted by facsimile or other electronic means shall have the same force and effect as an original signature.
