**RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of November 13, 2018 (this "Release"), is made by WHITE OAK GLOBAL ADVISORS, LLC, as collateral agent and secured party for the Lenders (the "Grantee"), in favor of SONAR ENTERTAINMENT, LLC (the "Grantor"). All capitalized terms used but not otherwise defined herein have the meanings assigned to them in the Credit Agreement (as defined below).

**WITNESSETH**

WHEREAS, Sonar Entertainment, Inc., Sonar Entertainment, LLC, the Grantee, and the other parties thereto entered into that certain Bridge Credit Agreement, dated as of December 9, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") and the Grantors and the Grantee entered into that certain Security, Pledge and Guaranty Agreement, dated as of December 9, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantor executed the Trademark Security Agreement dated as of December 9, 2016 (the "Trademark Security Agreement"), and recorded with the U.S. Patent and Trademark Office on December 9, 2016 at Reel/Frame No. 5945/0523, pursuant to which the Grantor granted to the Grantee, a continuing security interest in all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement); and

WHEREAS, the Grantor has requested that the Grantee release its security interest in all right, title and interest in, to and under the Trademark Collateral.


NOW, THEREFORE, in consideration of the foregoing, the Grantee hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Trademark Collateral, including, without limitation, the trademark registrations and applications set forth in Schedule A attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Grantee may have obtained in, to and under the Trademark Collateral under the Credit Agreement, the Security Agreement, and the Trademark Security Agreement.


