**TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY
AGREEMENT**

This TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Termination and Release") is made as of the 30th of November, 2018, by Silicon Valley Bank (the "Bank") to Mobi Wireless Management, LLC, an Indiana limited liability company (the "Grantor"). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Amended and Restated Loan and Security Agreement (defined below) and the Intellectual Property Security Agreement (defined below).

W I T N E S S E T H

WHEREAS, pursuant to that certain Loan and Security Agreement, dated as of May 18, 2015 (as amended and restated by that certain Amended and Restated Loan and Security Agreement, dated as of December 18, 2017, and as further amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Loan and Security Agreement"), by the Grantor in favor of the Bank, the Grantor executed that certain Intellectual Property Security Agreement, dated May 18, 2015 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Intellectual Property Security Agreement"), which was recorded in the United States Patent and Trademark Office, pursuant to which the Grantor granted a security interest to the Bank, in such Grantor's Patents and Trademarks, including certain patents, trademarks, patent applications and/or trademark applications listed on Schedule I hereto and made a part hereof.

WHEREAS, the Bank now desires to terminate and release its security interest in the Patents and Trademarks and reassign any and all rights, title, and interest in the same to Grantor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. the Bank hereby releases, terminates, and discharges its security interest in all of Grantor's right, title and interest in and to the Patents and Trademarks, including those patents set forth on Schedule I, including all goodwill associated with the Patents and Trademarks and all products and proceeds of the foregoing, including without limitation, any claim by any Grantor against third parties for past, present or future (i) infringement or dilution of any Patents or Trademarks or (ii) injury to the goodwill associated with any Patents or Trademarks;

2. if and to the extent that the Bank has acquired any right, title or interest in or to any of the Patents and Trademarks, the Bank hereby reassigns, grants and conveys to Grantor, without any representation, warranty, recourse or undertaking by the Bank, any and all of the Banks's right, title, and interest in and to such Grantor's Patents and Trademarks.
