TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of November 30, 2018, by WILMINGTON TRUST, NATIONAL ASSOCIATION, as collateral agent for certain secured parties (in such capacity, the "Collateral Agent"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, LEGACY SAFEGUARD, LLC, a Nevada limited liability company, PREMIER PLANNING, LLC, a Nevada limited liability company, and ADVANCE PLANNING SERVICES, LLC, a Nevada limited liability company (each a "Pledgor" and collectively, the "Pledgors"), and Collateral Agent were parties to that certain Trademark Security Agreement dated as of July 1, 2016 (the "Security Agreement") pursuant to which each Pledgor granted a security interest to Collateral Agent in certain Trademark Collateral (as defined below) as security for certain obligations owing by each Pledgor to Collateral Agent, including the trademark registrations and applications set forth on Schedule I hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on July 11, 2016, at Reel 5832, Frame 0557 to 0565;

WHEREAS, the Pledgors have requested that Collateral Agent terminate and release its security interest in and liens on the Trademark Collateral and reassign any and all rights in the same to such Pledgors; and

WHEREAS, the Pledgors have satisfied and fulfilled all of their obligations to release the Collateral Agent's security interest in the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Collateral Agent hereby terminates, releases and discharges its continuing security interest in and liens on each Pledgor's entire right, title and interest in and to any collateral in respect of which a security interest was granted to Collateral Agent under the Security Agreement, including the following, whether owned or existing at the time of the Security Agreement or thereafter created, acquired or arising (all such items or types of property being herein collectively referred to as the "Trademark Collateral"):

(i) each trademark registration and application listed on Schedule A annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark registration and application; and

(ii) all products and proceeds of the foregoing, including without limitation, any claim by any Pledgor against third parties for past, present or future (a) infringement or dilution of each such trademark registration and application, or (b) injury to the goodwill associated with each such trademark registration and application.

2. Collateral Agent hereby reassigns, grants and conveys to Pledgors, without any representation, recourse or undertaking by Collateral Agent, any and all of Collateral Agent's right, title and interest in and to the Trademark Collateral.

3. The laws of the State of New York shall govern all matters arising out of, in connection with or relating to this Trademark Release and Reassignment, including, its validity, interpretation, construction, performance and enforcement (including, any claims sounding in contract or tort law arising out of the subject matter hereof and any determinations with respect to post judgment interest).

4. This Trademark Release and Reassignment may be executed in any number of counterparts and delivered by facsimile or otherwise electronically, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same document.
