RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (this "Release"), effective as of November 29, 2018, is entered by HERCULES TECHNOLOGY II, L.P., a Delaware limited partnership ("Secured Party").

SHARETHIS, INC., ("Grantor"), a Delaware corporation with a principal place of business at 4005 Miranda Avenue, Suite 1000, Palo Alto, California 94304, and Secured Party are parties to that certain Loan and Security Agreement and Trademark Grant of Security Agreement, each dated as of December 14, 2012 (as supplemented or otherwise modified from time to time) (collectively, the "Security Agreements"). Secured Party hereby releases, discharges and terminates any and all liens and security interests that it may have in the Trademarks and associated goodwill pursuant to the Security Agreements, including, for the avoidance of doubt, the Trademarks listed on Schedule A. Secured Party confirms the release from such Security Agreements and all of the terms and conditions thereof, all right, title and interest in and to all such Trademarks, including such registrations, all associated goodwill, common law rights and any other right or interest therein.


This Release may be executed in any number of counterparts (including electronic transmission), each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.


