C.* §18-214 to convert Henkel Corporation, a Delaware corporation (the "Corporation"), to Henkel NA LLC, a Delaware limited liability company (the "Limited Liability Company"), and the undersigned does hereby certify as follows:

FIRST. The name of the Corporation is Henkel Corporation, and the name under which the Corporation was originally incorporated was General Mills Chemicals, Inc.

SECOND. The original certificate of incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on January 22, 1970. The Corporation was first created, incorporated, formed, or otherwise came into being on January 22, 1970 in the State of Delaware. Prior to the effectiveness of this Certificate, the Corporation is a Delaware corporation.

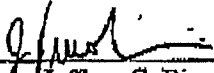
