**RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of October 2, 2013, and recorded in the United States Patent and Trademark Office on October 10, 2013 at Reel/Frame No. 5133/0785 (the “IP Security Agreement”; all capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed in or otherwise referenced in the IP Security Agreement), made by GRAYWOLF INDUSTRIAL, INC. (f/k/a Horn Intermediate Holdings, Inc.) (“Grantor”), in favor of WILMINGTON TRUST, NATIONAL ASSOCIATION, as administrative agent and collateral agent (in such capacity, together with its successors and permitted assigns, “Agent”), for the benefit of the Secured Parties, Grantor mortgaged, pledged and hypothecated to, and granted to, Agent a Lien on and security interest in, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the IP Security Agreement) including the registered trademark listed on Schedule A hereto (together with the Trademark Collateral, the “Released Collateral”);

WHEREAS, the Secured Obligations (other than the Surviving Obligations referred to in the letter agreement, dated the date hereof, among Agent, the Grantor and certain affiliates of Grantor) have been satisfied, discharged and paid in full, and all of the Agent’s security interest in and Lien on the Released Collateral has been released and terminated (without representation or warranty on the Agent’s part); and


WHEREAS, Agent wishes to provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release, relinquishment and discharge of its liens on and security interest in the Released Collateral;

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, Agent hereby, without any representation and warrant and without any recourse to Agent, terminates, cancels, reassigns, relinquishes, releases and discharges all liens and security interests it has on and in the Released Collateral and reassigns and reconveys any interest it has in the Released Collateral to Grantor.
