REASSIGNMENT OF TRADEMARKS

WHEREAS, WECHSLER COFFEE CORPORATION, a New Jersey corporation with its chief executive office located at 10 Empire Blvd., Moonachie, New Jersey 07074 (the "Company"), has heretofore assigned to BANKERS TRUST COMPANY, a New York banking corporation having an office at 280 Park Avenue, New York, New York 10017 (the "Bank"), by a Trademark Security Agreement dated as of February 22, 1985 (the "Agreement") made by the Company in favor of the Bank, recorded March 4, 1985 in the United States Patent and Trademark Office at Reel 0489, Frames 404-413, a security interest in the marks listed in Schedule I attached hereto (the "Marks"); and

WHEREAS, the Company and the Bank are desirous of having on record a reassignment from the Bank to the Company of all of its rights on the Marks;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Bank hereby releases its security interest in the Marks and the other "Collateral" referred to in the Agreement and hereby reassigns, without recourse, representation or warranty, express or implied, to the Company all of its right, title and interest (if any) in, to and under the Marks and the other "Collateral" referred to in the Agreement.

IN WITNESS WHEREOF, the Bank has caused this Reassignment of Trademarks to be executed as of this 24 day of September, 1988.
