RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (“**Release**”) is made and effective as of November 30, 2018, and granted by TEXAS CAPITAL BANK, NATIONAL ASSOCIATION, a national banking associate with offices at 2000 McKinney Avenue, Suite 700, Dallas (Dallas County), TX 75201, the secured party under the Security Agreements referred to below (the “**Secured Party**”), in favor of THEBLAZE INC., a Delaware corporation with offices at 6301 Riverside Drive, Las Colinas, Irving, TX 75039 (the “**Grantor**”), and its successors, assigns and legal representatives.

WHEREAS, the Secured Party and the Grantor are parties to (a) that certain LOAN AGREEMENT dated as of January 29, 2016 (as amended, modified, or restated from time to time, the “**Loan Agreement**”), (b) that certain SECURITY AGREEMENT dated as of January 29, 2016 (as amended, modified, or restated from time to time, the “**Security Agreement**”), (c) that certain TRADEMARK COLLATERAL SECURITY AGREEMENT (as amended, modified, or restated from time to time, the “**Trademark Security Agreement**”), and (d) that certain SECURITY INTEREST ASSIGNMENT dated as of January 29, 2016 (the “**Security Interest Assignment**” and together with the Loan Agreement and the Security Agreement, the “**Security Agreements**”);

WHEREAS, pursuant to the Security Agreements, the Grantor pledged and granted to the Secured Party a security interest in and to all of the right, title and interest of such Grantor in, to and under the Trademark Collateral (as defined below);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 5749, Frame 0775 on March 11, 2016 and

WHEREAS, the Grantor has requested that the Secured Party enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantor of any and all right, title and interest the Secured Party may have in the Trademark Collateral pursuant to the Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby states as follows:

1. Definition. The term “Trademark Collateral,” as used herein, shall mean all of Grantor’s right, title, and interest in and to (collectively, the “**Trademark Collateral**”) certain Collateral (as defined in the Trademark Security Agreement), including the Trademark Licenses (as defined in the Trademark Security Agreement), the Trademarks (as defined in the Trademark Security Agreement) and associated registrations set forth in Schedule A attached thereto.

2. Release of Security Interest. Secured Party, on behalf of itself and its successors, legal representatives and assigns, hereby terminates the Security Agreement, the Trademark Security Agreement, and the Security Interest Agreement, and terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreements in any and all right, title and interest of the Grantor, and reassigns to the Grantor any and all right, title and interest that it may have, in, to and under the Trademark Collateral.

3. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Texas, without giving effect to any choice or conflict of law provision or rule (whether of the State of Texas or any other jurisdiction).

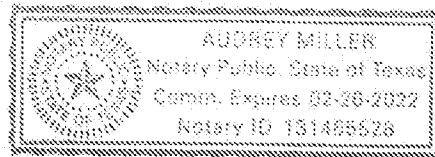
