Assignor warrants and represents that: (i) Assignor has full right, power and authority to enter into this Assignment and to convey the Mark to Assignee; (ii) Assignor has never granted and will not in the future grant any rights to any third parties that would violate, conflict with or otherwise be inconsistent with any term or provision of this Assignment; (iii) all intellectual property rights associated with the Mark are herein assigned via this Assignment; and (iv) Assignor has not granted any release, covenant not to sue, or non-assertion assurance to any third party with respect to the Mark.

In the event that any one or more of the provisions of this Assignment is held by a court of competent jurisdiction to be invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions will not in any way be affected or impaired thereby.

This Assignment shall be binding on the successors and assigns of Assignor and shall inure to the benefit of the successors and assigns of Assignee.


