**TRADEMARK ASSIGNMENT**

WHEREAS, Excellus Health Plan, Inc., a New York corporation, with offices at 165 Court Street, Rochester, New York 14647 (“Assignor”) has acquired or adopted, and used, and thereby owns rights, title and interests in and to (i) the trademark INQUIRY for certain goods in International Class 16; and (ii) the United States Registration thereof, namely U.S. Registration No. 0,871,806 (the “Mark”, and “Registration,” respectively), together with the goodwill of the business appurtenant to said Mark;



Assignor hereby agrees that Assignee shall have the right to record this instrument of assignment with the United States Patent and Trademark Office and with any other agency, office or authority in any and all other jurisdictions and countries of the world, so as to establish Assignee as owner of record of the Mark and Application.

Assignor further agrees, at the request of Assignee and without charge or cost to Assignee, to (i) execute and have executed any and all other documents of any kind whatsoever, and to provide whatever information may be required, to carry out the terms and intent of this Assignment; and (ii) fully cooperate with Assignee, as reasonably required, to enable Assignee to duly record this instrument of assignment with the United States Patent and Trademark Office and with any other agency, office or authority in any and all other jurisdictions and countries of the world, so that Assignee’s ownership of the Mark and Application is duly made of record.


