RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Security Interest in Intellectual Property is made as of 13 NOVEMBER, 2018, by China CITIC Bank International Limited, as security agent, ("Security Agent") acting for itself and on behalf of the Finance Parties (as defined in the Trademark Security Agreement described below) in favor of:

- 1) Country Inn & Suites by Radisson, Inc. (formerly known as Country Inns & Suites by Carlson, Inc.), a corporation incorporated in the State of Minnesota, the United States of America with its principal place of business located at P.O. Box 59159, Minneapolis, Minnesota 55459, United States of America;
- 2) Park Hospitality LLC, a limited liability company incorporated in the State of Delaware, the United States of America with its principal place of business located at Carlson Parkway, P.O. Box 59159, Minneapolis, Minnesota 55459, United States of America; and
- 3) Radisson Hotels International, Inc., a corporation incorporated in the State of Delaware, the United States of America with its principal place of business located at Carlson Parkway, P.O. Box 59159, Minneapolis, Minnesota 55459, United States of America

(collectively, the "Companies"),

Recitals

WHEREAS, the Companies granted to Security Agent a security interest in their U.S. trademarks, and the goodwill associated therewith, listed on Exhibit A attached hereto (the "Intellectual Property") under a Trademark Security Agreement dated as of April 5, 2017 among the Companies and Security Agent (the "Trademark Security Agreement");

WHEREAS, pursuant to the Trademark Security Agreement, the Companies were required to execute and deliver a Confirmation of Security Interest in Trademarks dated as of April 5, 2017 (the "Confirmation") to the Security Agent for purposes of filing with the United States Patent and Trademark Office ("USPTO");

WHEREAS, the Confirmation was recorded with the USPTO on April 6, 2017 at Reel/Frame 6029/0190 for Country Inns & Suites by Carlson, Inc.; at Reel/Frame 6039/0015 for Park Hospitality LLC; and at Reel/Frame 6029/0326 for Radisson Hotels International, Inc.;

WHEREAS, Companies have fully satisfied all of their obligations under the Trademark Security Agreement, and none of the Companies have outstanding obligations to Security Agent under the terms of the Trademark Security Agreement, and Security Agent has agreed to terminate the Trademark Security Agreement and release its security interest in all of the Intellectual Property; and



WHEREAS, Security Agent hereby agrees to execute any additional instruments, documents, or agreements as are necessary to effect the termination and release of the security interest in all of the Companies' Intellectual Property.

Agreement

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Security Agent hereby terminates the Trademark Security Agreement and terminates, discharges and releases any security interest in and lien upon all of the Intellectual Property under the Trademark Security Agreement, and reassigns, transfers, and conveys to Companies any and all right, title and interest of the Security Agent in the Intellectual Property, including but not limited to the associated goodwill in the Intellectual Property and any and all other rights it might have arising out of the Trademark Security Agreement.


