INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT, effective as of the 10th day of December 2018 (the “**Assignment**”), by and between BAYADA Health, LLC, a Delaware Limited Liability Company (“**BHLLC**” or “**Assignor**”), and Baiada Family, Inc., a Delaware corporation (“**BFI**” or “**Assignee**”), collectively “the **Parties**.”

WHEREAS Assignor is desirous of assigning to Assignee all right, title, and interest to the trademarks set forth in Exhibit A attached hereto, including, without limitation, all goodwill associated therewith (the “**Marks**”) and all right, title and interest in and to certain materials that have been registered with the United States Copyright Office, as set forth in Exhibit B hereto (the “**Copyrights**”), together with all goodwill arising from or relating thereto;

WHEREAS, Assignee is desirous of acquiring from Assignor all rights in and to the Marks and the Copyrights.

NOW, THEREFORE, in consideration of the covenants and agreements contained herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the Parties agree as follows:

1. Assignments.

(a) Trademark Assignment. Assignor hereby irrevocably conveys, transfers, assigns, and delivers unto Assignee, absolutely and forever, the entire right, title, and interest in the United States and throughout the world, in and to the Marks, including any corresponding trade dress, corporate names, trade names, or social media pages incorporating the Marks, whether statutory or at common law, together with all goodwill arising from or related to the business symbolized by the Marks, the same to be held and enjoyed by Assignee for its own use and enjoyment, and for the use and enjoyment of its licensees, successors, assigns, and/or other legal representatives, including the right to sue for and receive all damages accruing from past, present and future infringement of the Marks, to be used as fully and entirely as such rights would have been held and enjoyed by Assignor had this Assignment not been made. Assignor hereby represents and warrants to Assignee that it has the full right to convey the Marks herein assigned, the Marks do not infringe any third party’s rights, and there are no known infringements of the Marks by any third party. Assignor further covenants that it will not execute any agreement in conflict with this Assignment.

(b) Copyright Assignment. Assignor hereby sells, assigns, grants, and delivers to Assignee the entire right, title, and interest of every kind and nature whatsoever of Assignor, if any, in and to the Copyrights, including: (a) all rights of Assignor, if any, to obtain registrations, renewals, and extensions of the Copyrights, individually or collectively, that may be secured under the laws now or hereafter in force and effect in the United States, or in any other country or countries; and (b) all rights of Assignor, if any, to sue for all past infringements of the Copyrights, both at common law and under the statutes of the United States or any other country. Assignor does further consent to the recordation of this Assignment with any governmental agency.

2. Recordation.

(a) Trademark Recordation. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States of America, or with respect to any foreign trademarks or service marks or applications or registrations for such marks the foreign equivalent as the case may be, to record Assignee as owner of the Marks and to issue any and all registrations, including renewals thereof, to Assignee, its successors, assigns, nominees or other legal representatives.



Assignor hereby authorizes and requests the United States Copyright Office, or with respect to any foreign Copyrights, if any, the foreign equivalent as the case may be, to record Assignee as owner of the Copyrights and to issue any and all registrations, including renewals thereof, to Assignee, its successors, assigns, nominees or other legal representatives.

Assignor hereby constitutes and appoints Assignee as its true and lawful attorney-in-fact with full power of substitution, in Assignor's names and stead, to take all steps necessary to enforce any claim or right to take applications, registrations, renewals and extensions related to the Marks.


