RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of December 10, 2018 (this "Release"), is made by and among Bank of the West, acting in its capacity as administrative agent (in such capacity, the "Administrative Agent") under that certain Trademark Security Agreement, dated August 4, 2014 (as amended, restated, supplemented or otherwise modified, including by the Amended and Restated Trademark Security Agreement dated April 30, 2015, the "Trademark Security Agreement"), by and between Vision Integrated Graphics Group LLC, a Delaware limited liability company, f/k/a Vision Acquisition LLC and the successor to the interests of Tobe Direct LLC, a former Delaware limited liability company that has since been dissolved, (the "Grantor") and the Administrative Agent.

WHEREAS, pursuant to the Trademark Security Agreement, which was recorded in the records of the United States Patent and Trademark Office on August 7, 2014, at Reel 5339 / Frames 0038-0045, and the Amended and Restated Trademark Security Agreement, which was recorded in the records of the United States Patent and Trademark Office on May 14, 2015, at Reel 5516 / Frames 0501-0508, the Grantor granted to the Administrative Agent a continuing security interest in all of its right, title or interest in, to or under all Trademark Collateral (as defined in the Trademark Security Agreement), including the registrations listed on the attached Schedule I;

WHEREAS, pursuant to that certain Payoff Letter, dated as of the date hereof by and between the Grantor, the other signatories party thereto, and the Administrative Agent, the Grantor has requested and the Administrative Agent has agreed to (a) release any and all security interests it may have in the Trademark Collateral pursuant to the Trademark Security Agreement and (b) promptly execute any intellectual property security agreement releases evidencing and effecting the release, termination, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Trademark Collateral, (b) release and relinquish its security interest in, to or under all Trademark Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Administrative Agent in the Trademark Collateral. The Administrative Agent agrees, or authorizes the Grantor, to make filings with the United States Patent and Trademark Office and take further actions, as reasonably requested by the Grantor to evidence the release and termination of the Administrative Agent's security interests in the Trademark Collateral.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of Illinois.


