MASTER TRADEMARK ASSIGNMENT AGREEMENT

This Master Trademark Assignment Agreement is made between M T S, Incorporated ("MTS"), a California corporation, and Three A's Holdings, LLC, a Delaware limited liability company (collectively with MTS, "Assignor"), and Cumberland Corporate Services Ltd., a British Virgin Islands corporation ("Assignee"). *limited company (ASK)*

WHEREAS, Assignor is the owner of all rights, title and interest in and to the trademarks, trademark applications, and trademark registrations identified on Schedule A attached hereto (collectively the "Trademarks"); and

WHEREAS, Assignee is desirous of acquiring the Trademarks, and is desirous of acquiring the goodwill of the business symbolized by the Trademarks in such countries as the Trademarks are registered and in connection with such Trademarks as is deemed necessary by Assignee;

WHEREAS, Assignor is desirous of divesting the Trademarks, together with the goodwill of the business symbolized by the Trademarks;

WHEREAS, Assignor has agreed to assign all its right, title and interest in and to the Trademarks, including the goodwill of the business symbolized by the Trademarks, pursuant to the terms of a certain Asset Purchase Agreement of even date herewith (the "Asset Purchase Agreement") among MTS, Incorporated (the "Assignor" herein), Tower Direct, LLC, and Caiman Holdings, Inc., which has designated the Assignee to accept title to the Trademarks.

WHEREAS, Assignor and Assignee are desirous of executing a document for the purposes of recording title in and to the aforesaid Trademarks in the name of Assignee in the Trademark Offices in such countries and in connection with such Trademarks as is deemed necessary by Assignee;

NOW THEREFORE, for good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, Assignor does hereby assign, sell and transfer to Assignee, its successors and assigns all rights, title and interest in and to: (i) the Trademarks, including all applications and registrations thereof and the Certificates of Registration issued therefor, and any and all renewals thereof for the Trademarks, together with all goodwill pertaining thereto in such countries and in connection with such Trademarks as is deemed necessary by Assignee; (ii) all income, royalties, damages and payments which hereafter become due or payable in respect of the Trademarks; (iii) all causes of action (in law or equity) and rights to sue, counterclaim and/or recover for present or future infringement thereof; and (iv) all rights corresponding to the foregoing throughout the world.

Assignor hereby authorizes the appropriate empowered officials in the appropriate governmental offices in jurisdictions throughout the world to transfer all registrations and applications for the Trademarks to Assignee as assignee of the entire rights, title and interest therein, or otherwise as Assignee may direct, in accordance with this instrument of assignment, and to issue to Assignee all registrations which may issue with respect to any trademark

applications included in the Trademarks, in accordance with this Master Trademark Assignment Agreement.

Assignor hereby constitutes and appoints the Assignee its true and lawful attorney-in-fact, for the limited purposes set forth herein, with full power of substitution in the Assignor's name and stead but for the Assignee's benefit to take any and all steps (including proceeding at law, in equity or otherwise at Assignee's cost and expense), and to execute, acknowledge and deliver any and all instruments and assurances necessary or expedient in order to vest the aforesaid Trademarks, including all applications and registrations thereof and the Certificates of Registration issued therefor, and any and all renewals thereof for the Trademarks effectively in the Assignee. The Assignor hereby declares that the foregoing power is coupled with an interest and is irrevocable.

Assignor shall not contest or challenge, or aid any person or entity in so contesting or challenging, the validity of the Trademarks or Assignee's ownership thereof.

Assignor represents that it has the authority to make and enter into this Master Trademark Assignment Agreement.

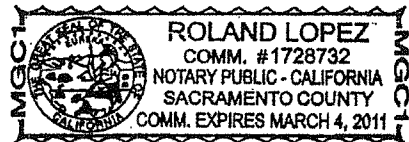

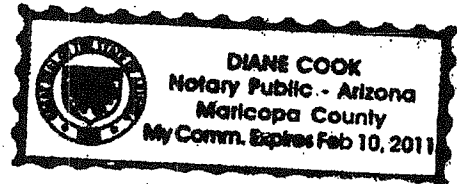
