Ladies and Gentlemen:

This will confirm that upon receipt of the Total Loan Payoff Amount as defined below before 4:00 p.m. (Central Standard Time) on April 7, 2011, all of the existing obligations of Rikco International, LLC, a Wisconsin limited liability company d/b/a Dr. Comfort ("Rikco"), to Associated Bank, N.A. (the "Bank") in connection with Loan Numbers 86856739001 and 86856739001 will be satisfied in full and all loan arrangements, liens, security interests, unfunded lending commitments, loan documents, agreements and all other obligations between the Rikco, Rikco Holding Corporation, a Delaware corporation ("Holdco" and together with Rikco, the "Company"), and the Bank will be terminated. Upon receipt of the Total Loan Payoff Amount, (a) all of the Bank's liens on and security interests in the Company's property shall be deemed to have automatically been terminated and released, (b) the Bank hereby authorizes the Company or the Company's designee(s) including, DJO, LLC, a Delaware limited liability company ("DJO"), to file Uniform Commercial Code ("UCC") termination statements and take any action related thereto, and (c) the Bank will promptly execute and/or deliver to Rikco or to such other party as Rikco may direct all promissory notes evidencing Rikco's debt to the Bank and such mortgage releases and other releases, terminations and satisfactions of the Bank's liens on, and security interests in, the Company's property as are necessary to evidence the satisfaction of the Company's obligations to the Bank and the termination of the Bank's interest in all collateral held with respect thereto, all at Rikco's expense. The foregoing shall include without limitation:

If no draw is made on such letter of credit as of the expiration thereof, or if funds remain after such expiration and after reimbursement for all obligations relating to any such draw, Bank will deliver such amount to Thomas Campion, as Member Representative for the former members of Rikco International, LLC d/b/a Dr. Comfort, Reinhart Boerner Van Deuren s.c., 1000 North Water Street, Suite 1700, Milwaukee, WI 53202.

The Bank acknowledges that DJO has agreed to purchase all of the issued and outstanding membership interests of the Rikco owned by Rikco's individual members and the Kanter Dynasty Trust and all of the issued and outstanding common stock of Holdco from Merit Mezzanine Fund IV, L.P. and Merit Mezzanine Parallel Fund IV, L.P. (the "Transaction"), and that DJO will rely upon the foregoing in connection with consummation of the Transaction.
