## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

December 12, 2018

**WHEREAS**, GERSON LEHRMAN GROUP, INC., a Delaware corporation (the “Grantor”), granted a security interest to Silicon Valley Bank, as Administrative Agent (the “Assignee”), for the ratable benefit of the Secured Parties, in and a lien upon certain Trademarks (then owned or at any time thereafter acquired by the Grantor or in which the Grantor had or at any time in the future may acquire any right, title, or interest) as set forth in that certain Collateral Agreement dated January 4, 2008 by the Grantor in favor of the Assignee (the “Security Agreement”), which was recorded in the United States Patent and Trademark Office on February 23, 2008 at Reel 3723, Frame 0351;

**WHEREAS**, the Grantor has requested that the Assignee release and reassign to Grantor its interest in all of the Grantor’s Trademarks including the Trademarks identified in Schedule A hereto and made a part hereof; and

**NOW, THEREFORE**, for good and valuable consideration, receipt of which is hereby acknowledged, Assignee hereby:

1. terminates the Security Agreement and releases and reassigns to Grantor any and all liens, security interests, right, title and interest of Assignee in or to the Trademarks, including the Trademarks identified in Schedule A and any goodwill associated with any of such Trademarks, along with the right to obtain renewals thereof, without recourse or representation or warranty, express or implied of any kind;
2. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given; and
3. agrees that it shall, at the Grantor’s sole cost and expense and at any of the Grantor’s, or its successor’s or assign’s, reasonable request, execute, acknowledge and deliver to the Grantor all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such security interest.

Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Security Agreement.


