**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) with an effective date of September 14, 2018, is made by Wilmington Trust, National Association, a U.S. national banking association, as term-priority collateral agent having an address at 50 South Sixth Street, Suite 1290, Minneapolis, MN 55402 (in such capacity as the “**Term-Priority Collateral Agent**”), to and in favor of Akima, LLC, a limited liability company of Alaska having an address of 13873 Park Center Road, Suite 127 Herndon, Virginia 20171 (“**Company**”).

WITNESSETH:

WHEREAS, Company and certain other entities executed a Term Pledge and Security Agreement, dated as of March 15, 2013, in favor of the Term-Priority Collateral Agent, and Company executed that certain Trademark Security Agreement, dated as of March 15, 2013 (the “**Trademark Security Agreement**”) in favor of the Term-Priority Collateral Agent, pursuant to which Company assigned and pledged a security interest in all of Company’s right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including under the trademarks, registrations and applications set forth in Exhibit A to this Release; and

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 004984, Frame 0108 on March 15, 2013; and

WHEREAS, the Term-Priority Collateral Agent has agreed to release all of its security interest in all of Company’s right, title and interest in, to and under the Trademark Collateral, and reconvey any and all rights in the Trademark Collateral to Company, including the trademarks, registrations and applications set forth in Exhibit A.


NOW, THEREFORE, in consideration of good and valuable consideration, receipt of which is hereby acknowledged, the Term-Priority Collateral Agent hereby releases, reconveys and relinquishes all of its right, title and interest in, to and under the Trademark Collateral that is the subject of the Trademark Security Agreement and reassigns to Company any and all right, title or interest it may have in such Trademark Collateral, including the trademarks, registrations and applications set forth in Exhibit A, all without warranty or representation of any kind.

The Term-Priority Collateral Agent hereby authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Release.
