(Under Minnesota statute 322C.1004)

FIRST: The name and form of each constituent organization and the jurisdiction of its governing statute which are parties to the merger are:

THIRD: The date the merger is effective under the governing statute of the surviving organization, ACBJ is January 1, 2018.


