

**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
CLEAR MOUNTAIN SPRING WATER, LLC**

For the purpose of amending the Articles of Organization of Clear Mountain Spring Water, LLC, an Arkansas limited liability company (the "Company"), under Act 1003 of the General Assembly of the State of Arkansas, known as the Arkansas Small Business Entity Pass-Through Act and any Act amendatory thereof, supplementary thereto or substituted therefor (hereinafter referred to as the "Act"), the Company does hereby amend said Articles of Organization as follows:

1. Article 1 of said Articles of Organization shall be amended to read as follows:

"1. Name. The name of the limited liability company, referred to in these Articles as the "Company" is: "Mountain Valley Spring Company, LLC."

2. Article 5 of said Articles of Organization shall be amended to read as follows:

"5. Registered Agent. The name and address of the Company's registered agent is Thomas C. Vaughan, Jr., 11300 Cantrell Road, Suite 201, Little Rock, Arkansas, 72212.

3. The above amendments were adopted by a unanimous action of its members at a special meeting of the members of the Company held on April 15, 2004. A copy of the resolutions regarding the name change and change of address of the registered agent is on file at the offices of the Company.

4. All of the outstanding membership interests/units voted for the above amendments and no units voted against the amendments.

5. Such amendments do not effect a change in the amount of stated capital or provide for an exchange, reclassification or cancellation of issued units.

IN WITNESS WHEREOF, the Company has caused these Articles of Amendment to be executed for the Company by its Managing Member.
