**TERMINATION AND RELEASE OF
ABL SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF ABL SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of October 11, 2018 (the "Effective Date"), is made by **DEUTSCHE BANK AG NEW YORK BRANCH**, in its capacity as collateral agent (the "ABL Collateral Agent"), in favor of **EMERGENCY MEDICAL SERVICES CORPORATION**, now known as ENVISION HEALTHCARE CORPORATION, a Delaware corporation with an address at 1A Burton Hills Boulevard, Nashville, Tennessee 37215 (the "Grantor").

WHEREAS, Grantor entered into that certain ABL Notice and Confirmation of Grant of Security Interest in Trademarks dated as of May 25, 2011, which was recorded by the United States Patent and Trademark Office on June 3, 2011 at Reel 4554, Frame 0373 (the "ABL Trademark Security Agreement");

Capitalized terms used but not otherwise defined herein have the meanings given to them in the ABL Trademark Security Agreement.

WHEREAS, Grantor granted the ABL Collateral Agent, under the terms of the ABL Trademark Security Agreement, a second priority security interest (the "Security Interest") in favor of the ABL Collateral Agent, in and to all of its Intellectual Property, including the Trademarks listed in Schedule 1 (the "Trademark Collateral").


WHEREAS, the ABL Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the ABL Collateral Agent hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantor, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest.
