The Seller shall at the Buyer's request and cost (as to out-of-pocket expenses only) execute any such further document and take any such further action as the Buyer may reasonably require to enable the Buyer to become registered as the proprietor of the Trade Marks including where the Trade Marks consist of applications for registration any action required to enable the applications to mature into registrations and to secure the benefits of the rights hereby assigned.
3. This agreement shall be governed by, and construed in accordance with, the law of England.


