Aura Software, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify as follows:

SECOND: Article I of the Certificate of Incorporation of the Corporation shall be amended and restated in its entirety as follows:

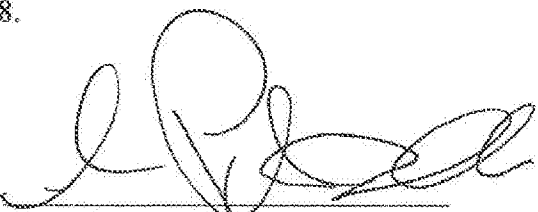
"The name of the corporation is Quoori, Inc. (the "Corporation")."
