**TRADEMARK RELEASE**

THIS TRADEMARK RELEASE is made as of December 14, 2018, by U.S. BANK NATIONAL ASSOCIATION, as Administrative Agent for certain lenders (“Secured Party”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, Plaskolite Tennessee, LLC, a Delaware limited liability company (“Grantor”) and Secured Party were parties to that certain Memorandum of Security Interest in Trademarks dated as of April 6, 2018 (the “Security Agreement”) pursuant to which the Grantor granted a security interest to Secured Party in certain Trademarks and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Secured Party, including the Trademarks set forth on Schedule 1 hereto;
