ASSIGNMENT OF TRADEMARK


WHEREAS, SPIN SCREED, INC. ("Spin Screed"), a corporation of the State of Illinois, is the owner of the registered trademark SPIN SCREED, U.S. Reg. No. 2,670,593 for electrically powered screeds for leveling unhardened concrete.

NOW, THEREFORE, in consideration of entering into Agreement and other good and valuable consideration, the receipt of which is hereby acknowledged, Spin Screed, does hereby assign, sell and convey to Marshalltown, the trademark SPIN SCREED and any designs therefore, together with the goodwill associated therewith, and including the right to sue for past infringement if any there may be. Spin Screed covenants that it will at any time hereafter, at Marshalltown's request, execute and deliver all other instruments necessary, in the opinion of Marshalltown's counsel, to complete or perfect the transfer of title to the trademark SPIN SCREED.

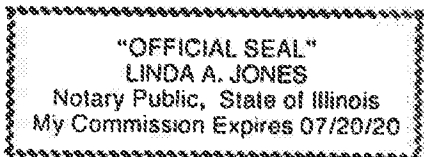
