## INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this "IP Assignment Agreement"), is executed as of July 31, 2018 ("Closing Date"), by and between ELECTROLUX HOME PRODUCTS CORPORATION, N.V., a company organized under the laws of Belgium, having its principal place of business at Rue de la Fusée 40, 1130 Bruxelles, Belgium ("EHCP Belgium" or "Assignor"), and BISSELL INTERNATIONAL FINANCE COMPANY, S.a.r.l., a private company organized under the laws of Luxembourg, having its principal place of business at 412F Route d'Esch, L-2086 Luxembourg ("Assignee"). Capitalized terms used but not otherwise defined herein shall have the respective meanings set forth in that certain Asset Purchase Agreement among Assignor, Assignee and certain Affiliates of Assignor of even date herewith ("Purchase Agreement").

### RECITALS

WHEREAS, Pursuant to Section 2.1 of the Purchase Agreement, Assignor have agreed to sell, assign, convey, transfer and deliver to Assignee, and Assignee has agreed to purchase and acquire from Assignor, all of Assignor's right, title and interest in, to and under the Acquired Assets, including Business Intellectual Property (as that term is defined in the Purchase Agreement); and

WHEREAS, Pursuant to Section 7.1(b) and 7.2(b) of the Purchase Agreement, Assignor and Assignee have agreed to enter into this IP Assignment Agreement to evidence the transfer of such Business Intellectual Property from Assignor to Assignee.

NOW THEREFORE, in consideration of the foregoing and the representations, warranties and agreements set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors and Assignee, intending to be legally bound, hereby agree as follows:

1. **Assignment of Business Intellectual Property.** Upon the terms set forth in the Purchase Agreement, Assignor hereby sells, assigns, conveys, transfers and delivers to Assignee, and Assignee hereby purchases and acquires from Assignor, all of Assignor's right, title and interest in and to the Business Intellectual Property, including without limitation the rights set forth on Schedule A attached hereto, all of the goodwill associated therewith and symbolized thereby, the right to sue for any and all past infringements thereof, and to receive any and all damages awarded as a result of any such claim, and all other rights and interests therein and thereto ("Assigned IP").

2. **Further Assurances.**

a. Assignor hereby covenants and agrees that it shall, at any time after the Closing Date or from time to time thereafter at the reasonable request of Assignee and at Assignee's expense, (a) execute and deliver such further instruments of sale, assignment, conveyance, transfer and delivery to Assignee as shall be reasonably necessary or appropriate to effectively consummate the assignments contemplated hereby, and (b) reasonably assist Assignee, at Assignee's request, in exercising Assignor's rights with respect thereto.



b. Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States of America, the United States Copyright Office, and all applicable officials of any other state or foreign agencies or authorities, governmental or otherwise, to issue or transfer all of the Assigned IP to Assignee, as assignee of the entire right, title, and interest therein or otherwise as Assignee may direct.

c. As and to the extent that any governmental or quasi-governmental office or agency pertaining to the filing, registration, application or processing of intellectual property, including without limitation the United States Patent and Trademark Office, the United States Copyright Office, and other state or foreign offices in which any of the Assigned IP listed in Schedule A is or was registered, applied for, pending or recorded, requests that additional forms or documents be presented or executed by Assignor or its agents, affiliates or attorneys, Assignor shall execute such documents and deliver them to Assignee or its agents, attorneys or designees, as applicable pursuant to Section 2a. above.

d. Assignor agrees to carry out, or have carried out for them, the formal transfer of the Domain Names to Assignee in accordance with the domain name transfer procedures of the Domain Name registrar or other current procedures as required to transfer ownership, registration and all other right, title and interest in the Domain Names to Assignee, including the delivery of the proper transfer codes to authorize the transfer of the Domain Names. Assignor agrees that until the account change is completed, Assignor will maintain the websites located at the Domain Names in a manner consistent with past practice.

**3. Successors and Assigns.** The terms and provisions of this IP Assignment Agreement shall be binding upon, and inure to the benefit of, Assignor and Assignee, and each of their respective successors and assigns.

**4. Third Party Beneficiaries.** Nothing in this IP Assignment Agreement is intended to or shall confer upon any Person other than the parties and their respective successors and assigns, any rights, benefits, or remedies of any nature whatsoever under or by reason of this IP Assignment Agreement or any transaction contemplated by this IP Assignment Agreement.

**5. Choice of Law.** This IP Assignment Agreement and the rights and obligations of the parties shall be governed by and shall be enforced and interpreted in accordance with the laws of the State of New York, without regard to conflicts of law doctrines.

**6. Counterparts.** This IP Assignment Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. Copies (facsimile, electronic or original) of signatures to this IP Assignment Agreement shall be deemed to be originals and shall be binding to the same extent as original signatures.

**7. Conflict.** The Purchase Agreement controls in the event of any conflict between this IP Assignment Agreement and the Purchase Agreement.

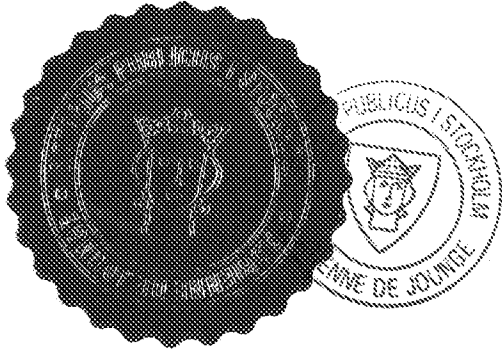

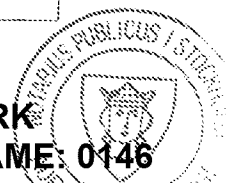
