**NUNC PRO TUNC ASSIGNMENT OF TRADEMARK



WHEREAS, this Nunc Pro Tunc Assignment is executed for the purpose of confirming said Prior Assignment of July 1, 2017 and, to the extent that said Prior Assignment is deemed invalid or unenforceable for any reason, for Assignor to presently assign, transfer and convey to Assignee all rights, title and interest in and to said mark and said '585 Registration, including all the goodwill associated with said mark and said '585 Registration, including, but not limited to, the goodwill of the business which is symbolized by said mark and said '585 Registration, as of the execution date of this Nunc Pro Tunc Assignment.

NOW THEREFORE, in consideration of the compensation in an amount agreed to by Assignor and Assignee and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby confirms that Assignor did assign, transfer and convey to Assignee, in the Prior Assignment, effective July 1, 2017, all rights, title and interest in and to said mark and said '585 Registration together with the goodwill assigned with said mark and said '585 Registration, including, but not limited to, the goodwill of the business which is symbolized by said mark and said '585 Registration. To the extent that said Prior Assignment

is deemed invalid or unenforceable for any reason, Assignee hereby assigns, transfers and conveys to Assignee all rights, title and interest in and to said mark and said '585 Registration together with the goodwill assigned with said mark and said '585 Registration, including, but not limited to, the goodwill of the business which is symbolized by said mark and said '585 Registration and further including the right to sue and recover for damages and all other remedies for past infringements of said mark.
