SCHEDULE B
FORM OF ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is dated as of December 13, 2018 (the "Effective Date") by and between CS Technology, Inc., a Delaware corporation ("CST") and SiteHands, Inc., a Delaware corporation ("SiteHands"). CST and SiteHands are referred to herein collectively as the "Parties", and individually as a "Party."

WHEREAS, CST wishes to transfer, contribute and assign to SiteHands, and SiteHands wishes to accept, all of the CST's right, title and interest in and to the registered and unregistered marks and/or trade names existing as of the Effective Date, including, without limitation, those set forth on the attached Schedule A hereto, together with the goodwill of the business associated therewith (collectively, the "Marks").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto hereby agree as follows:

1. CST hereby irrevocably assigns to SiteHands, and SiteHands accepts, (i) all of the CST's right, title, and interest in and to the Marks; and (ii) any and all legal actions and rights and remedies at law or in equity for past infringements, misappropriations, or other violations of the Marks, including the right to sue for, collect, and retain all damages, profits, proceeds, and all other remedies associated therewith. CST agrees to give SiteHands and/or any person designated by SiteHands all reasonable assistance that may be required to perfect the rights granted herein.

2. CST authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any other official throughout the world whose duty is to register and record ownership in trademark registrations and applications for registration of trademarks, to record the SiteHands as the assignee and owner of any and all of the CST's rights in the Marks.

3. All of the terms and provisions of this Assignment shall inure to the benefit of and be binding upon the parties hereto and their respective executors, heirs, personal representatives, successors and assigns.

4. No provision of this Assignment is intended to confer upon any person other than the parties hereto and their respective executors, heirs, personal representatives, successors and assigns any rights or remedies hereunder.

5. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement.

6. This Assignment shall be governed by and interpreted and enforced in accordance with the laws of the State of Delaware, without giving effect to any choice of Law or conflicts of Laws rules or provision (whether of the State of Delaware or any other jurisdiction) that would cause the application of the Laws of a jurisdiction other than the State of Delaware.
