RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE dated as of December 17, 2018 (this "Release") is made by SUNTRUST BANK, acting in its capacity as administrative agent for the Secured Parties (in such capacity, the "Agent") under that certain Trademark Security Agreement, dated as of November 30, 2015 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") between INTERCEPT INTERACTIVE INC. (the "Grantor") and the Agent. Capitalized terms used but not defined herein have the meanings provided in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded at the United States Patent and Trademark Office ("USPTO") on December 2, 2015 at Reel 5680 and Frame 0055, the Grantor granted to the Agent a continuing security interest in all of Grantor's right, title and interest in, to and under the Trademark Collateral, including those set forth on the attached Schedule A.

WHEREAS, the Grantor has requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Agent in the Released Collateral, and (d) reassigns, grants and conveys to the Grantor any and all right, title and interest it has in the Released Collateral.
