**TERMINATION AND RELEASE OF SECURITY INTEREST
IN COPYRIGHTS, PATENTS, TRADEMARKS AND
COPYRIGHTS, PATENTS, TRADEMARKS LICENSES**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN COPYRIGHTS, PATENTS, TRADEMARKS AND COPYRIGHTS, PATENTS, TRADEMARKS LICENSES**, dated as of December 19, 2018 ("Release"), is made by SUNTRUST BANK, as Administrative Agent ("Administrative Agent") in favor of LIFENET HEALTH, a Virginia nonstock corporation ("LifeNet") and SKIN AND WOUND ALLOGRAFT INSTITUTE, LLC, a Virginia limited liability company ("SWAI", and collectively with LifeNet, the "Grantor").

WHEREAS, pursuant to that certain Guaranty and Security Agreement dated as of November 10, 2015 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and among the Grantor, Administrative Agent, and others party thereto, Grantor granted to the Administrative Agent, for the benefit of the holders of the Secured Obligations ("Secured Parties"), a continuing security interest in, and a right to set off against, any and all right, title and interest of Grantor in and to all Copyrights and Copyrights Licenses, Patents and Patents Licenses, Trademarks and Trademark Licenses, and Proceeds of the foregoing (collectively, "Copyrights, Patents and Trademarks Collateral"); and

WHEREAS, pursuant to the Security Agreement, Grantor executed and delivered to Administrative Agent, for the benefit of the Secured Parties, the Intellectual Property Security Agreement recorded at the United States Patent and Trademark Office ("USPTO") on December 21, 2015 at Reel/Frame: 5693/0703 ("Notice").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Secured Parties, and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

SECTION 2. Termination and Release. Administrative Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in, and the right to set off against, Grantor's right, title, and interest in and to all the Copyrights, Patents and Trademarks Collateral, including, but not limited to, the foregoing listed on Schedule I attached hereto, granted pursuant to the Security Agreement or Notice; and

(b) authorizes the recordation of this Release with the USPTO at Grantor's expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Administrative Agent, on behalf of the Secured Parties, has caused this Release to be duly executed as of the date first set forth above.


