

## ASSIGNMENT OF TRADEMARK SECURITY INTEREST

THIS ASSIGNMENT OF TRADEMARK SECURITY INTEREST is made as of September 10, 2018, by WESTERN ALLIANCE BANK, an Arizona corporation (the "Assignor"), for the benefit of WOODFOREST NATIONAL BANK, a national banking association (the "Assignee").

WITNESSETH:

**WHEREAS**, ANDRE-BOUDIN BAKERIES, INC., a California corporation ("Boudin"), as borrower, BOUDIN HOLDINGS, INC., a Delaware corporation ("Holdings"), as holdings, Assignor (as successor in interest to Bridge Bank, National Association, as Agent) as agent and lender, entered into that certain Loan Agreement dated April 5, 2013 (as amended through the date hereof, the "Original Loan Agreement") whereby Assignor provided Boudin with a loan facility in an aggregate principal amount up to \$18,000,000 (the "Original Loan").

**WHEREAS**, in connection with the Original Loan, Assignor and BOUDIN IP, INC., a Delaware corporation ("Boudin IP") entered into that certain Patent and Trademark Security Agreement, dated as of April 5, 2013 (as amended through the date hereof, the "Security Agreement"), pursuant to which, among other things, Boudin IP granted a security interest to Assignor in all of Boudin IP's right, title and interest in and to the trademark registrations and applications set forth on Exhibit A attached hereto which is incorporated herein by this reference (the "Trademarks").

**WHEREAS**, the Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on April 5, 2013, at Reel 4999, Frame 0895;

**WHEREAS**, a certain Corrective Assignment was recorded with the PTO on April 10, 2013, at Reel 5002, Frame 0832, in order to correct the Assignor's name and address as previously recorded at Reel 4999, Frame 0895.

**WHEREAS**, pursuant to that certain Agreement for Purchase and Sale of Loan dated as of the date hereof and consummated immediately prior hereto (the "Loan Sale"), Assignor sold to Assignee and Assignee purchased from Assignor, all of Assignor's right, title and interest in the Original Loan, the Original Loan Agreement and the "Loan Documents" (as defined in the Original Loan Agreement).

**WHEREAS**, in connection with the Loan Sale, Assignor desires to assign to Assignee, and Assignee desires to accept and assume, all of Assignor's right, title and interest in and to the Security Agreement.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby irrevocably grants, transfers and assigns to Assignee, and Assignee hereby accepts and assumes from Assignor, the security interest granted by Boudin IP under the Security Agreement in all of Boudin IP's right, title and interest in and to the Trademarks.
