Assignor shall execute and deliver, from time to time after the date hereof upon the request of Assignee, such further conveyance instruments, and take such further actions, as may be necessary or desirable to evidence more fully the transactions contemplated hereby. All costs, expenses and responsibility of determining whether confirmatory assignments are necessary, preparing confirmatory assignments, and filing the same shall be borne by Assignor.

This Intellectual Property Assignment Agreement, and the rights and obligations of the parties hereunder, shall be governed by and construed in accordance with the laws of the State of New York.


