RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This **RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "*Release Agreement*") is dated as of October 10, 2018, by SILICON VALLEY BANK, a California corporation ("*Bank*").

WHEREAS, Zephyr Health, Inc., a Delaware corporation (the "*Grantor*"), executed and delivered an Intellectual Property Security Agreement dated as of March 22, 2018 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*IPSA*").

WHEREAS the IPSA granted the Bank a security interest in and lien on certain trademarks and trademark applications (collectively, "*Trademarks*") described therein, which was recorded with the Trademark Division of the United States Patent and Trademark Office ("*USPTO*") on March 26, 2018, at Reel 6354, Frame 0360;

WHEREAS the IPSA granted the Bank a security interest in and lien on certain patents and patent applications (collectively, "*Patents*") described therein, which was recorded with the Patent Division of the USPTO on March 26, 2018, at Reel 45351, Frame 0838;

WHEREAS, the Grantor has requested that the Bank release, discharge and terminate all liens and security interests granted to the Bank under the IPSA.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby (a) releases the Grantor from the IPSA, (b) releases, terminates and discharges all liens and security interests and all right, title and interest in, to and under the Trademarks and the Patents (including without limitation all goodwill associated therewith, including the Trademarks identified in Schedule A attached hereto and the Patents identified on Schedule B attached hereto, and (c) authorizes and requests that this Release of Intellectual Property Agreement be recorded at the USPTO.
