ASSIGNMENT AND ASSUMPTION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This ASSIGNMENT AND ASSUMPTION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT dated as of December 3, 2018, (this "Assignment and Assumption") is made by PNC Bank, National Association, as Existing Term Loan Agent (in such capacity, the "Assignor") and SJC DLF III-L, LLC, as Successor Agent (in such capacity, the "Assignee").

WHEREAS, pursuant to that certain Term Loan and Security Agreement, dated as of November 1, 2018, among BW EMPIRE HOLDINGS, LLC, a Delaware limited liability company ("Holdings"), NACS USA INC., a Delaware corporation ("NACS"), FLETCHER WOOD SOLUTIONS, INC., a Delaware corporation ("Fletcher"), COMANCHE INVESTMENTS, LLC, a Delaware limited liability company ("Comanche"), FAIRFIELD ROAD, LLC ("Fairfield"), a North Carolina limited liability company, ORNAMENTAL MOULDINGS, LLC, a Delaware limited liability company ("Ornamental Mouldings"), ORNAMENTAL PRODUCTS, LLC, a North Carolina limited liability company ("Ornamental Products"), L. J. SMITH, INC., an Ohio corporation ("L. J. Smith", and together with Ornamental Mouldings, Ornamental Products and Empire, the "Existing Grantors" and each an "Existing Grantor"), SOUTHWEST MOULDING CREATIVE WOOD PRODUCTS, LP, a Texas limited partnership ("Southwest Wood"), THE EMPIRE COMPANY, LLC, a Michigan limited liability company ("Empire"), SOUTHWEST MOULDING CO., LP, a Texas limited partnership ("Southwest Moulding"), SOUTHWEST MOULDING TRUCKING CO., LP, a Texas limited partnership ("Southwest Trucking"), and NOVO BUILDING PRODUCTS, LLC, a North Carolina limited liability company ("Novo LLC", and together with the Existing Grantors, Holdings, NACS, Fletcher, Comanche, Fairfield, Southwest Wood, Southwest Moulding, Southwest Trucking and Novo LLC, and each Person incorporated or organized under the laws of any State of the United States joined thereto as a borrower from time to time, collectively, the "Borrowers" and each individually, a "Borrower"), the other parties party thereto and the Assignor, as a term loan lender and agent (as heretofore amended, modified and supplemented, the "Existing Loan Agreement"), the Existing Grantors granted to the Assignor a security interest in, among other collateral, the Existing IP Collateral (as defined below);

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of November 1, 2018 and recorded on November 5, 2018 with the United States Patent and Trademark Office at Reel 6473, Frame 0500 (the "Existing IP Security Agreement"), the Existing Grantors granted to the Assignor a continuing security interest in all of the Existing Grantors' Trademarks (as defined in the Existing IP Security Agreement), including those set forth on Schedule A attached hereto (the "Existing Trademarks");

WHEREAS, pursuant to the Existing IP Security Agreement, dated as of November 1, 2018 and recorded on November 2, 2018 with the United States Patent and Trademark Office at Reel 047387, Frame 0813, the Existing Grantors granted to the Assignor a continuing security interest in all of the Existing Grantors' Patents (as defined in the Existing IP Security Agreement), including those set forth on Schedule B attached hereto (the "Existing Patents");

WHEREAS, pursuant to the Existing IP Security Agreement, dated as of November 1, 2018 and filed for recordation on November 2, 2018 with the United States Copyright Office, such filing attached hereto as Exhibit A, the Existing Grantors granted to the Assignor a continuing security interest in all of the Existing Grantors' Copyrights (as defined in the Existing IP Security Agreement), including those set forth on Schedule C attached hereto (the "Existing Copyrights", and together with the Existing Trademarks and the Existing Patents, the "Existing IP Collateral");

WHEREAS, among others, the Assignor and the Assignee have entered into that certain Amended and Restated Term Loan and Security Agreement, dated as of the date hereof, among the Borrowers, AWM ACQUISITIONS CORPORATION, a Maryland Corporation ("AWM"), ORNAMENTAL INVESTMENTS, L.L.C., a North Carolina limited liability company ("Ornamental Investments"), EMPIRE SW LP, LLC, a Michigan limited liability company ("Empire LP"), EMPIRE/SOUTHWEST GP, LLC, a Texas limited

liability company ("Empire GP"), CWP/SMT GP, LLC, a Texas limited liability company ("CWP"), NOVO BUILDING PRODUCTS COMPANY, a Delaware corporation ("Novo Company"), and KOK'S WOODGOODS, LLC, a Michigan limited liability company ("Koks", and together with AWM, Ornamental Investments, Empire LP, Empire GP, CWP and Novo Company, and any other Person who may hereafter guarantee payment or performance of the whole or any part of the Obligations, collectively, the "Guarantors" and each individually, a "Guarantor"), the Assignor, as Existing Term Loan Agent, and the Assignee, as a Lender and Successor Agent (as heretofore amended, modified and supplemented, the "A&R Loan Agreement"), whereby the Assignor transferred to the Assignee, among other things, all of the Assignor's rights and obligations under the Existing Loan Agreement and Existing IP Security Agreement;

WHEREAS, the Assignor wishes to transfer all of its rights and obligations under the Existing IP Security Agreement to the Assignee pursuant to the A&R Loan Agreement, and the Assignee wishes to obtain from the Assignor, all of the Assignor's rights and obligations under the Existing IP Security Agreement, including the secured rights in the Existing IP Collateral; and

WHEREAS, pursuant to the A&R Loan Agreement, the Existing Grantors have reaffirmed their grant to the Assignee of a continuing security interest in, among other collateral, the Existing IP Collateral;



Capitalized terms used but not defined herein shall have the meanings ascribed to them in the A&R Loan Agreement. This assignment is made in accordance with and subject to the A&R Loan Agreement. In the event of any inconsistency between the terms and conditions of the A&R Loan Agreement and this assignment, the terms of the A&R Loan Agreement shall control.



INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement (this “Agreement”) is made as of this 1<sup>st</sup> day of November, 2018, by ORNAMENTAL PRODUCTS, LLC, a North Carolina limited liability company (“Ornamental Products”), ORNAMENTAL MOULDINGS, LLC, a Delaware limited liability company (“Ornamental Mouldings”), L. J. SMITH, INC., an Ohio corporation (“L. J. Smith”) THE EMPIRE COMPANY, LLC, a Michigan limited liability company (“Empire”), and ORNAMENTAL MOULDINGS COMPANY, a Nova Scotia unlimited liability company (“Ornamental Mouldings Company”, and together with Ornamental Products, Ornamental Mouldings and Empire, collectively the “Grantors” and each a “Grantor”), in favor of PNC BANK, NATIONAL ASSOCIATION, in its capacity as agent for the Lenders defined below.

WHEREAS, pursuant to that certain Term Loan and Security Agreement, dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, including all exhibits and schedules thereto, the “Credit Agreement”), among Grantors, BW EMPIRE HOLDINGS, LLC, a Delaware limited liability company (“Holdings”), NACS USA INC., a Delaware corporation (“NACS”), FLETCHER WOOD SOLUTIONS, INC., a Delaware corporation (“Fletcher”), COMANCHE INVESTMENTS, LLC, a Delaware limited liability company (“Comanche”), FAIRFIELD ROAD, LLC, a North Carolina limited liability company (“Fairfield”), SOUTHWEST MOULDING CREATIVE WOOD PRODUCTS, LP, a Texas limited partnership (“Southwest Wood”), SOUTHWEST MOULDING CO., LP, a Texas limited partnership (“Southwest Moulding”), SOUTHWEST MOULDING TRUCKING CO., LP, a Texas limited partnership (“Southwest Trucking”), NOVO BUILDING PRODUCTS, LLC, a North Carolina limited liability company (“Novo LLC”), and THE EMPIRE CANADA COMPANY LTD., an Ontario corporation (“Empire CN”, and together with the Grantors, Holdings, NACS, Fletcher, Comanche, Fairfield, Southwest Wood, Southwest Moulding, Southwest Trucking, Novo LLC and each other Person joined thereto from time to time as a borrower, collectively the “Borrowers”), the lenders from time to time party thereto (the “Lenders”), and PNC Bank, National Association, as agent for Lenders (“Agent”), the Lenders agreed to make certain financial accommodations available to Borrowers from time to time pursuant to the terms and conditions thereof; and

WHEREAS, pursuant to the Credit Agreement, each Grantor is required to execute and deliver to Agent, for the benefit of the Lenders, this Agreement.

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby agrees as follows:

1. DEFINED TERMS. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Credit Agreement.
2. GRANT AND REAFFIRMATION OF SECURITY INTEREST. To secure the payment and performance of the Obligations under the Credit Agreement, each Grantor hereby grants to Agent for its benefit and the benefit of the Lenders, and hereby reaffirms its prior grant pursuant to the Credit Agreement of a continuing security interest in and Lien on all of such Grantor’s right, title and interest in, to and under the following, whether presently existing or

hereafter created or acquired (collectively, the “IP Collateral”), with power of sale to the extent permitted by law:

(a) all of such Grantor’s copyrights and copyright applications (collectively, “Copyrights”) and all of the goodwill of the business connected with the use of, and symbolized by, each Copyright, including without limitation those referred to on Schedule 1 hereto;

(b) all of such Grantor’s patents and patent applications (collectively, “Patents”), and all of the goodwill of the business connected with the use of, and symbolized by, each Patent, including without limitation those referred to on Schedule 1 hereto;

(c) all of such Grantor’s trademarks, trademark applications, service marks, trade names, mask works (collectively, “Trademarks”), and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark, including without limitation those referred to on Schedule 1 hereto;

(d) all reissues, continuations or extensions of the foregoing; and

(e) all products and proceeds of the foregoing, including without limitation any claim by such Grantor against third parties for past, present or future infringement or dilution of any Copyright, any Patent, or any Trademark.

3. SECURITY FOR OBLIGATIONS. This Agreement and the security interest created hereby secure the payment and performance of all the Obligations under the Credit Agreement, whether now existing or arising hereafter. Without limiting the generality of the foregoing, this Agreement secures the payment of all amounts which constitute part of the Obligations and would be owed by any Grantor to Agent, the Lenders or any of them pursuant to the Credit Agreement.

4. CREDIT AGREEMENT. The security interests granted pursuant to this Agreement are granted in conjunction with the security interests granted to Agent, for the benefit of the Lenders, pursuant to the Credit Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of Agent with respect to the security interest in the IP Collateral made and granted hereby are more fully set forth in the Credit Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

5. REPRESENTATIONS, WARRANTIES AND AGREEMENTS. Each Grantor hereby represents and warrants to, and agrees with Agent and Lenders as follows: (A) Schedule 1 hereto accurately lists all registered IP Collateral as of the date hereof and (B) other than the Liens granted to Agent hereunder, such Grantor has not granted any Liens on any of its IP Collateral to any other Person.

6. AUTHORIZATION TO SUPPLEMENT. If any Grantor shall obtain rights to any new IP Collateral, this Agreement shall automatically apply thereto. Each Grantor shall give prompt notice in writing to Agent with respect to any such new IP Collateral. Without limiting any Grantor’s obligations under this Section 6, each Grantor hereby authorizes Agent unilaterally to modify this Agreement by amending Schedule 1 to include any such new IP Collateral of such Grantor identified in such written notice provided by such Grantor. Notwithstanding the foregoing, no failure to so modify this Agreement or amend Schedule 1 shall in any way affect,

invalidate or detract from Agent's continuing security interest in all IP Collateral, whether or not listed on Schedule 1.

7. GOVERNING LAW. This Agreement and the transactions contemplated hereby, and all disputes between the parties under or relating to this Agreement or the facts or circumstances leading to its execution, whether in contract, tort or otherwise shall, in accordance with Section 5-1401 of the General Obligations Law of the State of New York, be construed in accordance with and governed by the laws (including statutes of limitation) of the State of New York, without regard to conflicts of law principles that would require the application of the laws of another jurisdiction.

8. COUNTERPARTS. This Agreement may be executed in any number of counterparts, each of which shall be deemed to be an original, but all such separate counterparts shall together constitute but one and the same instrument. Any signatures delivered by a party by facsimile transmission or by e-mail transmission shall be deemed an original signature hereto.






