**ASSIGNMENT OF TRADEMARKS**

This Assignment of Trademarks (this "Assignment"), effective as of October 3, 2018 (the "Effective Date"), is made and entered into by and between the Jamul Indian Village of California, a federally-recognized indian tribe (the "Tribe") and the Jamul Indian Village Development Corporation, a tribal enterprise of the Jamul Indian Village of California, a federally recognized Indian tribe ("JIVDC").

**RECITALS**

A. The Tribe is the owner of the trademarks registered or pending in the United States Patent and Trademark Office as set forth in Exhibit A attached hereto (the "Trademarks").

B. The Tribe desires to transfer to JIVDC all right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the registrations and application thereof as set forth in Exhibit A.

C. The parties desire that the assignment of the Trademarks identified in Exhibit A be made of record with the United States Patent and Trademark Office.

NOW THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows.

1. **Assignment.** The Tribe, as of the Effective Date, hereby assigns, transfers, conveys and delivers to JIVDC, and JIVDC hereby acquires, assumes and accepts from the Tribe, all of the Tribe's right, title, and interest in and to the Trademarks, worldwide, including any causes of action relating to the Trademarks, claims for damages, profits and costs, both in equity and law, for any infringement or infringements of the Trademarks rights accruing on or before the Effective Date, together with the good will of the business symbolized by the Trademarks, and including the registrations and pending application therefor as set forth in Exhibit A.

2. **Further Assurances; Authorization.** The Tribe will timely execute and deliver any additional documents as may be required to complete the transfer, recordation or perfection of the Trademarks to JIVDC. The Tribe hereby authorizes and requests the Office of the Commissioner for Trademarks of the United States and any other official of any applicable governmental authority to issue any and all registrations from any and all applications for registration included in the Trademarks to and in the name of JIVDC.




