RELEASE OF SECURITY INTEREST IN TRADEMARKS

October 16, 2018

WHEREAS, AFN, LLC (the “Company”) entered into that certain Credit and Security Agreement (as amended, amended and restated, restated, supplemented modified or otherwise in effect from time to time, the “Agreement”), dated as of December 5, 2017, with **BMO HARRIS BANK N.A.**, in its lender (together with successors and assigns, “Grantee”). Capitalized terms used herein but otherwise not defined herein shall have the meanings ascribed to them in the Agreement; and

WHEREAS, pursuant to the Agreement, the Company executed and delivered to the Grantee that certain Grant of a Security Interest -- Trademarks, dated as of December 5, 2017 (as amended, amended and restated, restated, supplemented, modified or otherwise in effect from time to time the “Grant”), which Grant was recorded with the United States Patent and Trademark Office on December 6, 2017 at Reel 6222, Frame 0190; and

WHEREAS, pursuant to the Grant and the Agreement, the Company granted to the Grantee a security interest in the Company’s Trademarks (as defined in the Grant), including, without limitation, the trademark registrations and application identified on Schedule A attached hereto.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby terminates, cancels, discharges and releases all of its security interest in, to and under the Collateral (as defined in the Grant) and Trademarks (as defined in the Grant). including, without limitation, the trademark registrations and application identified on Schedule A attached hereto, effective as of the date first set forth above (the “Released Trademarks”). If and to the extent that the grantee has acquired any right, title or interest in and to the Released Trademarks under the Agreement, the Grantee hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Company.

This release shall be governed exclusively under the laws of Illinois, without regarding to conflicts of law or choice of law principles.

The Grantee acknowledges that this document may be filed with the United States Patent and Trademark Office to evidence the termination and release granted herein.
