**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

Capitalized terms used herein, unless otherwise defined herein, shall have the meanings ascribed to such terms in the Trademark Security Agreement.

This Release of Security Interest in Trademarks (this "Release") is intended to operate as a release of all liens and security interests conveyed by Company to Administrative Agent pursuant to the terms of the Trademark Security Agreement, and to reassign to Company all of Administrative Agent's right, title, and interest acquired pursuant to the terms of such Trademark Security Agreement.
