RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of October 17, 2018 ("Effective Date") in favor of EFA, INC., a North Carolina corporation (the "Company"), by SUNTRUST BANK ("SunTrust").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, SunTrust hereby (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all security interests it has against the Trademarks, and (iii) re-assigns to Company any right, title and interest it may have in, to and under the Trademarks to Company.


