**WHEREAS**, Assignor is the owner of all right, title, and interest in and to the trademark registrations and applications set forth on **SCHEDULE I** attached hereto (the "**Trademarks**"); and

**WHEREAS**, Assignee wishes to acquire all rights that Assignor has in and to the Trademarks, together with the goodwill of the business which is symbolized by the Trademarks, along with the right to recover for damages and profits for past infringements thereof.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell and assign unto Assignee all of Assignor's right, title, and interest in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks, along with the right to recover for damages and profits for past infringements thereof.

This Trademark Assignment will be registered in any countries that do not require an individual original assignment. The Parties agree that individual assignments consistent with this Trademark Assignment will be executed and recorded as required by the laws of the individual country. The Parties have agreed that Assignee will be responsible for (1) the preparation and recordal or registration of any updates in the chain of title for the registrations of the Trademarks, including, without limitation, any name and address changes from any prior owners of the Trademarks, or from Russell Corporation to Russell Brands, LLC; (2) the recordal or registration of this Trademark Assignment; (3) the preparation and recordal or registration of any additional assignments or other documents; and (4) all costs, fees and expenses associated with any and all of the foregoing. The Purchase Price for the assignment of the Trademarks is set forth in the Purchase Agreement between Assignor and Assignee. Upon Assignee's reasonable request, Assignor agrees to execute all documents necessary to assign Assignor's right, title and interest to the Trademarks as set forth in **SCHEDULE I**.

This Trademark Assignment will be governed by the laws of the Commonwealth of Kentucky without regard to any choice of law or conflict of laws principles and as applicable to contracts to be entered into and performed entirely within the commonwealth of Kentucky. The parties hereby consent to the exclusive jurisdiction and venue in the state and federal courts in Warren County, Kentucky, for the resolution of any dispute arising out of this Trademark Assignment or any document delivered pursuant thereto.

This Trademark Assignment may be executed by any number of counterparts and by different Parties on separate counterparts, each of which, when executed and delivered, is an original, and all of which, when taken together, are one and the same agreement.

All powers are granted to the bearer of the original of this Agreement to register it with any country that accepts this Agreement.

The Assignor undertakes to execute and/or deliver to the Assignee, at the Assignee's sole costs and expense, within thirty (30) days of its request and delivery of document to Assignor, all such documents consistent with the terms of this Trademark Assignment as may be necessary to file this Trademark Assignment with such competent bodies as may be required by the laws of the countries set forth on SCHEDULE I to this Trademark Assignment, except to the extent Assignor may be prohibited by law from signing such documents.

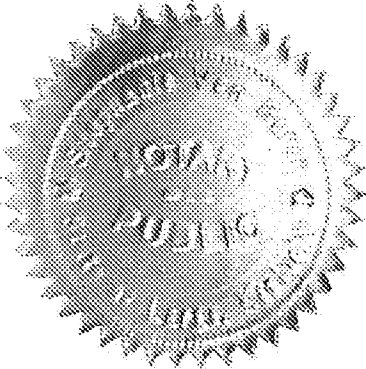

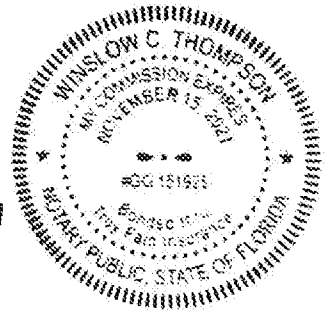
