**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of November 1, 2018, by, **JEFFERIES FINANCE LLC**, a Delaware limited liability company (the “Collateral Agent”) in favor of **MICHAEL BAKER INTERNATIONAL, INC.**, a Pennsylvania corporation, with an address at 100 Airside Drive, Moon Township, PA 15108 (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor entered into a certain Trademark Security Agreement dated November 21, 2017 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on November 21, 2017 at the United States Patent and Trademark Office at Reel 6210, Frame 0637.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to its Trademark Collateral, including the Trademarks listed in **Schedule A**.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in such Trademark Collateral as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest.


