## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks dated December 27, 2018 by BANK OF MONTREAL, with its mailing address at First Canadian Place, Asset Based Lending, 1st Floor, Toronto, Ontario, Canada M5X 1A1, acting as administrative agent hereunder for the Secured Creditors as defined in the Security Agreement referred to below (Bank of Montreal acting as such administrative agent being hereinafter referred to as the "*Agent*");

### WITNESSETH:

WHEREAS, Cossette Communication Group Inc., a company organized in the Province of Quebec ("*Debtor*"), with its mailing address at 801 Grande-Allee West, Suite 200, Quebec, Quebec G1S 1C1, and Agent were parties to a certain Trademark Collateral Agreement dated November 27, 2008 between Debtor and Agent which was recorded in the United States Patent and Trademark Office on December 19, 2018 at Reel 003906, Frame 0933 (the "*Agreement*"), pursuant to which Debtor granted to Agent, a security interest in, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "*Trademark Property*"); and

WHEREAS, Debtor has requested that Agent release its security interests in the Trademark Property and reassign the same to Debtor;


NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

- (i) Each trademark, trademark registration, and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application; and
- (ii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration, or trademark application listed on schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages.
