KG, a German limited partnership, with an address of record at Krossenundgraben/Heckel Tischmstrasse 2-4, Remscheid-Hasten, Germany (hereinafter "Assignor GmbH"), was the owner of and was listed in the United States Patent and Trademark Office ("USPTO") record as the registrant of US Registration No. 407705 covering the trademark set forth on the annexed Schedule A (hereinafter "the Trademark"); and

WHEREAS, Hanspeter Schlieper, the sole proprietor of Assignor s.K., became deceased on or about November 17, 2014; and

WHEREAS, the county court for Düsseldorf, Germany, appointed as Administrator of the Estate of Hanspeter Schlieper to administer the estate, including the estate of Assignor GmbH and Assignor s.K., as set forth in the court's order annexed hereto as Schedule B (all Assignors and Administrators of the Estate of Hanspeter Schlieper hereinafter collectively referred to as "Assignor"); and

WHEREAS, Tenety Mountain Knit Works, a Tennessee corporation with an address at 2120 Windfield Drive Finley, Sevierville, TN 37876 (hereinafter "Assignee") desires to acquire the Trademark and the goodwill symbolized thereby; and

WHEREAS, the Assignor is willing to assign all right, title, and interest in and to the Trademark, together with the goodwill symbolized thereby, to Assignee;

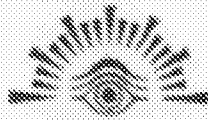
