**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 28, 2018 (“Release”), is made by BSP Agency, LLC as Successor Agent to Business Development Corporation of America, as Administrative Agent (“Administrative Agent”) in favor of Responsive Innovations, LLC, an Ohio limited liability company (“Grantor”).

WHEREAS, pursuant to that certain Security and Pledge Agreement dated as of June 30, 2015 (as amended, modified, extended, supplemented or restated from time to time, the “Security Agreement”) by and among the Grantor, Administrative Agent, and others party thereto, Grantor granted to the Administrative Agent, for the ratable benefit of the Lenders, a continuing security interest in Grantor’s right, title and interest in and to all Trademarks, Trademark Licenses, and Proceeds of the foregoing (collectively, “Trademark Collateral”);

WHEREAS, pursuant to the Security Agreement, Grantor executed and delivered to Administrative Agent, for the benefit of the Lenders, the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office (“USPTO”) on July 9, 2015 at Reel 5573 Frame 0232 (“Notice”);

WHEREAS, pursuant to the Successor Agent Agreement dated as of March 1, 2018 (“Successor Agent Agreement”) and the Notice of Succession of Agency (Intellectual Property) dated as of March 1, 2018 (“Notice of Succession”), the security interest granted under the Security Agreement was transferred from Business Development Corporation of America as Prior Agent to BSP Agency, LLC as Successor Agent; and

WHEREAS, the Notice of Succession was recorded at the USPTO on May 10, 2018 at Reel 6329 Frame 0184.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Lenders, and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement, Notice, Successor Agent Agreement, or Notice of Succession, as applicable.

SECTION 2. Termination and Release. Administrative Agent, on behalf of the Lenders, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in and to, Grantor’s right, title, and interest in and to Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement, Notice, Successor Agent Agreement, or Notice of Succession; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Administrative Agent, on behalf of the Lenders, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
