FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, Seller hereby sells, assigns, transfers, conveys and delivers to Buyer, any and all of the Seller's worldwide right, title and interest in and to any trademarks, service marks, logos, trade, corporate, or doing business as names, slogans, and other source indicators (i) containing the term "Turtle Bay" or (ii) used in connection with the Property, including without limitation, the Trademarks set forth on Exhibit A hereto (collectively, the "Trademarks"), together with:

1. All goodwill associated therewith, and all common law rights related thereto;
2. All rights, claims, credits, judgments, remedies, choses in action, rights under express or implied warranties from suppliers, causes of action, rights of recovery, interests in or claims, rebates, refunds or payments from or against vendors, rights of set-off, or rights to sue for past, present or future infringement against third parties to the extent arising out of, relating to or in respect of the foregoing; and
3. All rights of priority under any international conventions and any other international agreements to which the United States adheres, all income, royalties, damages, claims, and payments now or hereafter due or payable with respect to the foregoing, and all rights corresponding thereto throughout the world.

The above assignment by Seller to Buyer of all right, title and interest of Seller in and to the foregoing is made without any warranty or recourse, other than as set forth in the Purchase Agreement, including any implied warranty of merchantability, fitness for any ordinary use, or fitness for any intended use or particular purpose; it being understood that, other than as set forth in the Purchase Agreement, Buyer takes the Trademarks "as is" and "where is".

Seller hereby covenants and agrees that it will execute and deliver such documents reasonably requested by Buyer as may be necessary to evidence and effect the sale, assignment, transfer and conveyance of the foregoing to Buyer.

This Assignment is given pursuant to the terms and conditions of the Purchase Agreement, and is intended to convey fully the rights and interests required thereby to be conveyed with respect to the Intellectual Property being assigned to Buyer hereunder.

This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which, together, shall constitute one and the same instrument.

This Assignment shall be binding upon and inure to the benefit of the successors, assigns, personal representatives, heirs and legatees of the respective parties hereto.

In the event of the bringing of any action or suit by a party hereto against another party hereunder by reason of any breach of any of the covenants, conditions, agreements or provisions on the part of the other party arising out of this Assignment, then, in that event, the prevailing party shall be entitled to have and recover from the other party all costs and expenses of the action or suit, including, without limitation, reasonable attorneys' fees.

This Assignment shall be governed by, interpreted under, and construed and enforced in accordance with the laws of the State of Hawai'i.
