
NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the parties agree as follows:

3. **Governing Law.** The laws of the State of Texas shall govern this agreement and the parties hereby submit to the exclusive jurisdiction of the State and Federal courts located in Dallas County, Texas for the purpose of enforcing any claim arising under or in connection with this agreement.
