TRADEMARK RELEASE, TERMINATION AND REASSIGNMENT

THIS TRADEMARK RELEASE, TERMINATION AND REASSIGNMENT is made as of October 24, 2018, by ANTARES CAPITAL LP, as collateral agent (“**Collateral Agent**”) in favor of Clements National Company, a Delaware corporation (“**Clements**”), SRI Hermetics, LLC, a Delaware limited liability company (“**SRI Hermetics**”), TRU Corporation, a Massachusetts corporation (“**TRU**”), Winchester Electronics Corporation (“**Winchester Electronics**”) and Winchester SRC Cables Corp., a Delaware corporation (“**Winchester SRC**”; each of Winchester SRC, Clements, SRI Hermetics, TRU and Winchester Electronics, a “**Grantor**”, and collectively, the “**Grantors**”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Grantors and Collateral Agent were parties to that certain Trademark Security Agreement dated as of June 30, 2016 (the “**Security Agreement**”) pursuant to which the Grantors granted a security interest to Collateral Agent in certain Trademarks and IP Collateral as security for certain obligations owing by Grantors to Collateral Agent, including the Trademarks set forth on **Schedule 1** hereto;

WHEREAS, the Security Agreement was recorded by the United States Patent and Trademark Office on June 30, 2016, at Reel 5822, Frame 0841;

WHEREAS, Grantors have requested that Collateral Agent release its security interest in the Trademarks and IP Collateral and reassign any and all rights in the same to Grantors; and

WHEREAS, the Collateral Agent acknowledges that the conditions for termination of its security interest in the IP Collateral have been met, and accordingly, the Collateral Agent has agreed to execute this Trademark Release, Termination and Reassignment.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Collateral Agent hereby terminates, cancels, releases and discharges its security interest in and to the IP Collateral. Collateral Agent hereby terminates the Security Agreement.


2. Collateral Agent hereby reassigns, grants and conveys to each Grantor, without any representation, recourse or undertaking by Collateral Agent, any and all of Secured Party’s right, title and interest in and to the Trademarks and the IP Collateral.

3. Collateral Agent agrees, at Grantors’ expense, to cooperate with Grantors, to take all further actions and to provide Grantors with the information and additional authorization reasonably required or desirable to effect the purpose of this Trademark Release, Termination and Reassignment. Collateral Agent hereby authorizes and requests that the Commissioner for Trademarks of the United States Patent and Trademark Office record this Trademark Release, Termination and Reassignment. This Trademark Release, Termination and Reassignment shall be governed by, and construed in accordance with, the laws of the State of New York.
