
RESOLVED: That the Articles of Incorporation be amended in order to change the name of the corporation to BRANDT'S FRUIT TREES I, INC.;

DECLARATION OF LYNNELL BRANDT

I, Lynnell Brandt, hereby declare and state the following:


I am the President of Brandt's Fruit Trees I, Inc. This company was known as BRANDT'S FRUIT TREES, INC. until November 26, 2014, when the company name was changed to BRANDT'S FRUIT TREES I, INC. A copy of the corporate Certificate of Amendment showing the name change is attached hereto.

Between November 26, 2014 and the present, I authorized the filing of the U.S. trademark applications identified in Appendix A attached hereto. At the time the referenced applications were filed, the company name was BRANDT'S FRUIT TREES I, INC. but the company name was erroneously listed in the applications as BRANDT'S FRUIT TREES, INC., unintentionally omitting the "I" after "Trees."

The owner of the referenced trademarks should have been identified as BRANDT'S FRUIT TREES I, INC. The error in naming the owner was the result of years of habit in using the old company name, and was made in good faith, without deceptive intent.

The signatory, being warned that willful false statements and the like are punishable by fine or imprisonment, or both, under 18 U.S.C. § 1001, and that such willful false statements and the like may jeopardize the validity of the application or submission or any registration resulting therefrom, declares that all statements made of his own knowledge are true and all statements made on information and belief are believed to be true.
