RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this “Release”) is made as of December 31, 2018 by HERCULES CAPITAL, INC., in its capacity as collateral agent and administrative agent (in such capacity, the “Agent”) for the Lender (as defined in the Loan and Security Agreement referred to in the Security Agreement (as defined below)).

W I T N E S S E T H:

WHEREAS, WRIKE, INC., a Delaware corporation (“Grantor”), executed that certain Intellectual Property Security Agreement, dated as of January 23, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”) in favor of the Agent, pursuant to which the Grantor granted a security interest to the Agent in, among other collateral, certain trademarks of Grantor; and

WHEREAS, in connection with said Security Agreement, documentation was recorded with the United States Patent and Trademark Office on January 27, 2017 at Reel 5974, Frame 0273 to evidence Agent’s security interest in such trademarks of Grantor; and


WHEREAS, the Agent has agreed to release all its liens on the trademarks of the Grantor identified on Exhibit A attached hereto and made a part hereof (collectively, the “Released Collateral”), and to reconvey any and all rights in the Released Collateral to the persons legally entitled thereto.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases all its rights in and to the Released Collateral and reconveys to the persons legally entitled thereto all of the Agent’s right, title and interest in and to the Released Collateral, all without warranty or representation of any kind.
