TRADEMARK ASSIGNMENT

Assignee is to hold all right, title and interest in and to the Mark as fully and exclusively as it would have been held and enjoyed by Assignor had the sale, assignment, grant, conveyance, transfer and delivery in this Assignment not been made.

2. Parties Bound. This Assignment shall be binding upon and inure to the benefit of Assignor and Assignee and their respective successors and assigns.


