**This Trade Mark ASSIGNMENT is dated the 14<sup>th</sup> day of September 2018**

**BETWEEN:**

- (1) Speedy Stash Limited, incorporated and registered in England and Wales with company number 06206337 of Unit 6 Darby Close Cheney Manor Industrial Estate, Swindon, SN2 2PN (the "Assignor"); and
- (2) Clifton Concepts Ltd, incorporated and registered in Hong Kong with company number 2468632 of 62 Mody Road, Unit 1213, 12/F Wing On Plaza TST East, Hong Kong (the "Assignee").

**BACKGROUND:**

- (A) The Assignor is the owner of US trade mark registration number 5319938 (as listed in the schedule to this Assignment) and hereafter referred to as "the Trade Mark".
- (B) The Assignor has agreed to assign ownership of the Trade Mark to the Assignee on the terms set out in this Assignment.

**AGREED TERMS:**

**1. Assignment**

In consideration of the sum of £2,500 (two thousand five hundred pounds) (receipt of which the Assignor expressly acknowledges), the Assignor hereby assigns to the Assignee absolutely with full title guarantee all rights, the title and any interest in and to the Trade Mark, including:

all statutory and common law rights attaching to the Trade Mark, together with the goodwill of the business relating to the goods or services in respect of which the Trade Mark is registered or used; and

all rights to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action (including passing off) arising from ownership (if registered), of the Trade Mark whether occurring before, on or after the date of this agreement.

**2. Further Assurance**

The Assignor hereby covenants with the Assignee that the Assignor will at the expense of the Assignee execute sign and do all such instruments, applications, documents, acts and things as may reasonably be required by the Assignees to enable the Assignee or its nominees to enjoy the full benefit of the rights hereby assigned.

This agreement constitutes the entire agreement between the parties and supersedes and extinguishes all previous agreements, promises, assurances, warranties, representations and understandings between them, whether written or oral, relating to its subject matter.

**3. Governing Law and Jurisdiction**

This Agreement shall be governed by and interpreted in accordance with the laws of England and the parties hereby submit to the exclusive jurisdiction of the English courts.
